THIS LOAN MODIFICATION AGREEMENT made on June 03, 2009, by and between and (the "Borrower(s)") and America's Servicing Company , ("Wells Fargo Bank, N.A. doing business as America's Servicing Company )

## WITNESSETH

WHEREAS, Borrower has requested, and America's Servicing Company has agreed, subject to the following terms and conditions, to a modification of the note as follows:

NOW THEREFORE, in consideration of the covenants hereinafter set forth and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties, it is agreed as follows (notwithstanding anything to the contrary contained in the Note and Mortgage):

- BALANCE. As of June 03, 2009, the amount payable under the Note and Mortgage (the "Unpaid Principal Balance") is U.S. \$ 116,411.92.
- EXTENSION. This agreement hereby modifies the following terms of the Note and Security Instrument described herein above as follows:
  - A. The current due date has been extended from 01-01-09 to 08/01/2009.
  - B. The maturity date has been extended from 06-36 to 06/01/2036.
  - C. The amount of interest to be capitalized will be U.S. \$5,856.97. The modified unpaid principal balance is U.S. \$124,856.64.
  - D. The borrower promises to pay the unpaid principal balance plus interest, to the order of the Lender. Interest will be charged on the inpaid principal balance of U.S. \$ 124,856.64.
